As per the instruction of the Govt. of India, Ministry of Health and Family Welfare, Temporary Registration of the Doctor is mandatory.

We have to ensure that the application must be **received by the Medical Council of India at least two months before the scheduled date of commencement of training/practice** in India failing which the application may be liable to be rejected by the Central Government. /MCI.

Following documents are required:

1. Copy of provisional degree or diploma or certificate having passed the medical examination issued by the Dean of the college /university.
2. Copy of current registration certificate in your own country duly attested.
3. A certificate from the Head of the Institution under which the candidate is employed / to be employed to the effect that services rendered by the foreigner are for the purpose of teaching, research or practice medicine in India and not for personal gain. (We will provide this)
4. Copy of passport duly self attested.
5. Copies of all degree/diploma duly self verified.
6. Sponsorship letter from the institute/hospital in India.
7. Non refundable application fee of Rs. 5000/- (Rupees Five Thousand only) by a bank draft in favor of "The Secretary, Medical Council of India", payable at New Delhi. On reverse of the draft, following details to be filled by the applicant and duly signed: -
  - a. Name
  - b. Father's name
  - c. Purpose for which the draft submitted
  - d. Telephone no with code/mobile no.
